Student Union Fee Collection Notice

Academic Year 2017/2018

Vice- President of Students Office,

Attached is the schedule of Alma Mater Society of UBC Vancouver fees for the upcoming 2017/18 academic year. The document highlights changes to the majority of existing fees.

All fees except the SUB Renewal, Athletics and Intramurals Benefit, Student Legal Fund, Graduating Class, SUB Renewal, U- Pass fee, Campus Culture and Performance, and AMS Financial Assistance Fund Fees are indexed to the British Columbia Consumer Price Index. The recorded year- over- year rate on inflation for January was 2.3% thus the AMS fees adjust accordingly. However, the Health and Dental fee will be increased by 2.4% to adjust to the cost of the plan and the Campus Culture and Performance fee as per the referendum that passed last year will increase by \$0.25 annually.
