

EXECUTIVE SUMMARY

In April 2010, the Board of Governors approved the results of a student referendum that authorized that a Graduate Student Society fee of \$250.00 be collected by UBC for all students enrolled in the Master of Management program and is payable at the time of the first tuition instalment payment. The Graduate Student Society approved the fee in February 2010. In the 2010 resolution, the program was erroneously referred to as the “Early Career Master” program.

In May 2010, the Board of Governors approved a Student Building Fee to be paid once per student while enrolled in the “Early Career Master” program or the “Master of Management in Operations Research” program. The fee commenced at the completion of the Henry Angus Building renewal project to support a \$5M mortgage that was amortised over 35 years. The Board determined that the fee would be adjusted annually according to changes in the BC Consumer Price Index. The fee will be \$1,063.42 for the 2017-2018 academic year and is payable at the time of the first tuition instalment payment for all students enrolled in the Vancouver campus program. In the May 2010, resolutions, the programs were erroneously named.

The name of the Ministry-approved program is Master of Management, the name that appears on graduates’ parchments. The Administration intends to correct the error, in the Calendar, by listing the fees as the Master of Management fees: the Master of Management Student Society Fee and the Master of Management Student Building Fee.

DESCRIPTION & RATIONALE	The Early Career Master Society Student Fee of \$250.00 will be renamed the Master of Management Student Society fee, consistent with the Ministry-approved name for the program.

The “Early Career Master” Student Building Fee and the “Master of Management in Operations Research Student Building Fee” will be renamed the Master of Management Student Building Fee, consistent with the Ministry-approved program name. The latter fee of \$1,063.42 will be payable at the time of the first Master of Management tuition instalment payment, effective May 2017, for all students enrolled in the Vancouver program.

These fees are applicable for all Master of Management direct-entry students, as well as for students enrolled in the UBC Bachelor + Master of Management Dual Degree program. For students in the Bachelor + Master of Management Dual Degree program, the fees will be assessed at the time of the first Master of Management tuition instalment payment, after completion of the baccalaureate program.
