

**EXECUTIVE SUMMARY**

Development and Alumni Engagement reports to the Board of Governors twice per annum at Q2 and YE on key results, impact and initiatives.

In FY 2016-2017, \$181.9 million was raised from outright gifts and commitments to UBC with multi-year payment schedules. This result was consistent with the previous fiscal year. \$161.4 million was received, which reflects outright gifts and payments received on pledges committed to prior fiscal years.

Engagement with UBC’s alumni remains strong with 65,222 alumni engaged, surpassing last year’s total of 57,702.
