

To Whom It May Concern:

As a voting member of the British Columbia Federation of Students (BCFS) your association has agreed to act as agent for BCFS, with respect to the collection and remittance of membership fees.

Article 2, Section 1i sets out that the BCFS membership fees are adjusted each academic year by the rate of change in the national Consumer Price Index (CPI) during the previous calendar year. This letter is to advise you that based on the increase from 130.4250 in 2017 to 133.3800 in 2018—
—an increase of 2.2657 percent—the fee per individual member for the 2019-20 academic year will be \$9.34 per semester.

Please remit all membership fees to the BC office at 207-245 East Columbia Street, New Westminster, British Columbia, V3L 3W4.

At the January 2016 general meeting, a resolution was passed amending the BCFS membership fee, as outlined above. The resolution provided a period for the fee to be implemented by member locals, which expires on December 31, 2019. If the amended fee as listed above has not yet been implemented by your local, the fee for the Fall 2019 semester will be \$4.67.

Please notify your institution or other agent as soon as possible that this is the amount to be collected as Federation membership fees for the 2019-20 academic year. Also, please inform me at p.patigdas@thebcfs.ca upon receiving confirmation that the adjustment has been implemented.
