PRIOR SUBMISSIONS

Allocation of incremental 2020-2021 tuition revenue was most recently considered by the Finance Committee in [September 2021](#).

EXECUTIVE SUMMARY

At the April 2021 meeting, the UBC Board of Governors approved allocation to student support initiatives of incremental revenue arising from 2020-2021 Board-approved tuition rate increases (\$18 million comprising \$15.2 million at UBCV and \$2.8 million at UBCO). The Board also provided direction that up to \$4 million may be spent through Academic Excellence Funds (AEF) specific to Quarantine Bursaries.

The monthly forecasting and reporting process ensures that funds remain fully allocated as well as capturing potential new initiatives in anticipation of fully spending the funds by year end. Ongoing monitoring will ensure that a repository of opportunities to re-purpose unspent funds where appropriate is maintained.

Any unspent funds will be re-purposed based on the same criteria originally used to allocate the \$18 million, outlined below:

- The request must be for Student Financial Aid, cost of living support (housing, food security) and hybrid learning initiatives
- The request must be for new initiatives to support student facing COVID-19 related expenses
- The expenditure must be unplanned and/or is an unforeseeable deviation from the FY22 approved budget
- The request must be a *one-time* expenditure
- Reimbursements of prior year deficits will not be considered
- All requests must receive pre-approval prior to expenditures. Reimbursements of prior expenditures will not be considered

As of September 30, 2021, both UBCV and UBCO allocations remain fully committed against the entire \$18 million in funding for FY21-22.

EXECUTIVE SUMMARY

The Student Affordability Task Force (SATF) began meeting in June 2021 and has hosted eight meetings since that time. Task force membership includes students, faculty, and staff (see list below) from both the Vancouver and Okanagan campuses.

Discussion topics and presentations have focused on two sets of related questions. The first concerns a conceptual understanding of student affordability and an understanding of the scope of the university's commitments towards affordability. Given the complexity involved in this exercise, task force members are working through the various aspects of the question in an iterative manner, taking into account various stakeholder perspectives and the available literature.

The second set of issues for the task force comprise the known challenges UBC students face in terms of affordability. These include: the financial aid process; food insecurity; housing costs; cost of educational materials (over and above tuition and fees); the availability of scholarships; the allocation of financial aid between merit-based and need-based criteria, tuition and aid for international students; student loan and debt burden; and, financial literacy and proper distribution of finance-related information to students so as to enable optimal financial decisions.

The task force has identified the following focus areas for formulating its first set of recommendations:

1. Develop a multi-year tuition framework
2. Revise the annual tuition consultation process
3. Minimize costs of educational materials wherever possible (beyond course fees + tuition)
4. Address cost of living challenges (food, housing, child care, etc.) through needs-based aid
5. Update processes and procedures for the implementation of financial aid
6. Devote the next phase of the Blue & Gold Campaign to need-based aid
7. Advocate for increased and improved student financial assistance programs at the provincial and federal government level
8. Consider the expansion of Board of Governors Policy LR10 eligibility (Financial Aid Policy) to address international student needs
9. Develop appropriate mechanisms and tools for enabling students to make informed financial decisions
10. Link student survey data and administrative data to provide the administration with more real-time insight on affordability concerns and trends

Some of the recommendations can be developed and implemented in the short-term while others require a longer-term approach. Some of them will require additional funding and some require process improvements.

The SATF will continue to meet through the end of the calendar year to finalize recommendations and determine funding and implementation requirements. Its recommendations will then be brought to the Board as they are formulated and implementation will follow Board approval.

Anticipated Timeline

November 2021: Update on the work of the Task Force to date, indicating areas of requested feedback and potential recommendations to the Board

December 2021 to February 2022: Further analysis, costing and prioritization of recommendations

March 2022: Presentation of report and recommendations to the Board of Governors
