To Whom It May Concern:


As a voting member of the British Columbia Federation of Students (BCFS) your association has agreed to act as agent for BCFS, with respect to the collection and remittance of membership fees.

Article 2, Section 2.3a sets out that the BCFS membership fees are adjusted each academic year by the rate of change in the national Consumer Price Index (CPI) during the previous calendar year. This letter is to advise you that based on the increase from 136.9583 in 2020 to 141.6083 in 2021-an increase of 3.395 percent-the fee per individual member for the 2022-23 academic year will be \$9.91 per semester.

Please remit all membership fees to the BC office at 207-245 East Columbia Street, New Westminster, British Columbia, V3L 3W4.

Please notify your institution or other agent as soon as possible that this is the amount to be collected as Federation membership fees for the 2022-23 academic year.
