#### **PRIOR SUBMISSIONS**

The subject matter of this submission was previously considered by the Finance Committee on <u>April 19, 2018</u> (OPEN SESSION). Action: Tuition approval for the Master of Urban Forestry Leadership full-time program option.

#### **EXECUTIVE SUMMARY**

The Master of Urban Forestry Leadership (MUFL), offered by the Faculty of Forestry, is a professional coursebased master's program offered fully online. First launched in September 2021, MULF is a 30-credit, 13-month full-time program, based on a comprehensive, interdisciplinary perspective of urban forestry with strong emphasis on governance and strategic management of urban forests. Currently the only registration option available to students is the full-time, 13-month program. The Faculty is seeking approval to create a part-time, 25month option.

Providing a part-time option will enable the program to more successfully support working professionals who may be already working with aspects of urban forestry (in the public, private or not-for-profit sector), but who want to upgrade their knowledge, skills and networks. For these mid-career professionals, a part-time option would be advantageous for their career development, as at this point in their careers they have many personal, financial and professional commitments. Retaining an employee who can immediately apply their learnings from the classroom to their work is also beneficial for the employer. Including working professionals also enhances the program as the students bring their current projects to the classroom to share with their fellow students. Being able to provide a part-time opportunity will reduce the numbers of declines and deferrals and boost the overall registration into the program. It is expected that part-time students would be able to maintain full-time employment and therefore would have more financial stability throughout their studies.

Proposed tuition fees for the part-time program are equivalent to the current full-time MUFL program, but will be spread over eight instead of four instalments. The table below summarizes this proposal using 2023-2024 rates.

\*Continuing Fees for the full-time option are currently approved at \$5,306.04 for domestic students and \$9,746.10 for international students. The Faculty has presented a separate motion this Board cycle to reduce continuing fee rates for domestic and international students to align with standard master's degree program for the full-time option.

Recognizing the high international tuition differential, the Faculty has committed to offer up to 10 awards of \$10,000 each to international students. Funding for the awards will come from tuition revenue. The program, across both options, aims to enrol up to 25 students, where approximately 50% are international. These scholarships will be available to students in the full-time option, per the existing Senate Policy on Student Awards.

The Office of the Vice-President Students conducted a student consultation regarding the tuition proposal (as per Policy LR4). The e-consultation was conducted from November 03, 2022 to December 03, 2022. Submissions were received from the GSS and the AMS.

- The AMS is in favour of the proposed part-time offering and appreciate the continued offering of online learning which will allow the students, who are mainly working professionals, to be able to attend to their other responsibilities and can contribute to alleviating financial stress.
- The GSS raised questions related to the tuition proposal, primarily as it relates to the tuition differential between domestic and international students. The Faculty of Forestry responded to these questions and concerns in a follow up letter noting that the consultation at this time is regarding the new payment schedule for the proposed part-time study option, rather than consultation on the tuition fees charged since those were set in 2018. The Faculty also provided the requested benchmarking against comparator programs and noted that they intend to offer ten \$10,000 award to international students to help reduce the tuition margin. Unfortunately, at the time of consultation, the Faculty hoped to offer these awards to eligible international students in *either* the full-time or part-time option, however the Faculty has since learned that, per the existing Senate Policy on Student Awards, only full-time students will be eligible. A follow-up email was sent to the GSS clarifying this information.

This new part-time option does not require any changes in the program structure, courses or the ways in which the program is delivered. The part-time students join the same courses as the full-time students, but do fewer courses per term and finish the program in 25 months instead of 13. No further financial resources are required to launch or deliver this part-time iteration of the MUFL program program and it will be entirely delivered using existing teaching and support resources within the Faculty.

The Faculty hopes to offer the part-time option starting in September 2023.

The MULF full-time iteration was approved by the Board of Governors in April 2018. At that time, the Board approved a non-refundable acceptance deposit of \$1,000 for both domestic and international students, but due to an administrative oversight, the creation of this acceptance deposit was not approved by the President. A memorandum signed by the President is attached to this Board submission approving a recommendation that allows the MULF program to charge a \$1,000 non-refundable acceptance deposit to both domestic and international students in both the full-time and part-time iterations.

Acceptance deposits are credited towards the first tuition instalment, and forfeited by students who accept an offer of admission and then fail to register or decline the offer after the fact, unless there are extenuating circumstances.

# **STUDENT TUITION CONSULTATION REPORT**

# Mode of Consultation

The consultation consisted of an e-consultation. Student representative groups were invited to the consultation through email, and asked to distribute the invitation to their constituents as they felt appropriate. Student representative groups were also offered a face-to-face/zoom meeting to discuss the tuition proposal. A meeting was not requested by student representatives.

**Basis of Consultation:** The consultation was based on a tuition proposal and rationale document created by the Faculty. Please see Appendix 1 for the invitation and tuition rationale document.

**Timelines:** The e-consultation was conducted over the period of Thursday November 3, 2022 to Saturday December 3, 2022.

**Summary of Student Feedback:** Submissions were received from the AMS and the GSS. The verbatim submissions are in Appendix 2.

No individual student submissions were received.

# Tuition Proposal for Consultation MASTER OF URBAN FORESTRY LEADERSHIP (MUFL)

# PROGRAM OVERVIEW

The proposal under consultation represents a proposed change to the existing Master of Urban Forestry Leadership (MUFL) offered by the Faculty of Forestry. This is a professional course-based master's program which is offered fully online. Currently the only registration option available to students is a full-time, 13-month program and we wish to now create a new part-time, 25-month option.

Highly-qualified urban forestry professionals are becoming increasingly necessary in cities around the world due to the rapid pace and scale of urbanization, the need to adapt to multiple impacts of climate change in cities, and increasing demand from the public for the recreational, psychological, and health benefits that trees and greenspaces provide.

By the end of the program, students are able to:

- Lead urban forestry programs and projects, and coordinate interdisciplinary teams.
- Understand the political, governance, legal, administrative and business contexts of urban forestry, and connect urban forestry issues to wider government and other agendas.
- Understand the specific challenges and opportunities associated with growing trees and other vegetation in urban areas.
- Compile, use and present information on key aspects of urban forestry, such as urban forest resources, ecosystem services, arboriculture and urban woodland management, and interactions between people and trees.
- Engage with communities and other partners in developing and implementing urban forestry programs and projects.
- Work with urban forestry in local, national and international contexts.

First launched in September 2021, MULF is a 30-credit, 13-month program, based on a comprehensive, interdisciplinary perspective of urban forestry with strong emphasis on governance and strategic management of urban forests. The program has an international focus, with students, teachers and case studies deriving from different parts of the globe. It is targeted for professionals with urban forestry related work experience in the public, private or not-for-profit sector, but also recent graduates from the UBC Bachelor of Urban Forestry program or similar programs.

During program development it was intended to offer the program using a mixed delivery model, with a short 3-credit online component in the beginning, followed by a 21 credit on-campus component. The final 6-credit capstone course can be done off-campus, based on individual student interests and/or their employer's needs. Due to the COVID-19 pandemic, the program launched 100% online. Based on student feedback, continuing to offer the program online is the preferred mode of delivery as the majority of students are working professionals. Due to family, work and financial reasons, moving to Vancouver would not have been a possibility for most of them.

Being able to provide a part-time opportunity will reduce the numbers of declines and deferrals and boost the overall registration into the program. It is expected that part-time students would be able to maintain full-time employment and therefore would have more financial stability throughout their studies.

#### CONSULTATION DURING THE PROGRAM DEVELOPMENT PROCESS

The focus of the program is on professionals who already work with aspects of urban forestry (in the public, private or not-for-profit sector), but who want to upgrade their knowledge, skills and networks to reflect the current state-of-the art of urban forestry at the international level.

For these mid-career professionals, a part-time option would be advantageous for their career development, as at this point in their careers they have many personal, financial and professional commitments. Retaining an employee who can immediately apply their learnings from the classroom to their work is also beneficial for the employer. Including working professionals enhances the program as the students bring their current projects to the classroom to share with their fellow students.

Support for the inclusion of a part-time option was noted during our alumni survey (627 respondents) conducted prior to launching program:

- 69% of the respondents considered the flexibility in terms of when courses are delivered as very important or important
- 60% considered the flexibility in terms of how courses are delivered (e.g., availability of online courses) as very important or important

The Exit Survey of the first cohort (2021-2022) of students showed the importance of the part-time option. Many students tried to work full or part-time while studying, but soon found that extremely difficult. They would have preferred a part-time option for a number of reasons, including financially (keeping employment, longer payment period for the tuition) and academically (more time for studies to fully absorb the learnings). We have heard similar comments from applicants who decided in the end not to accept our offer and through several urban forestry conferences where we have marketed the program to working professionals.

We have also received feedback regarding the high international tuition fees (\$37,128) for the program, especially as it is offered online. We will be providing up to eight \$10,000 awards to students who demonstrate financial need, especially those from lower income countries.

# **TUITION AND FEES RATIONALE**

The proposed tuition fees for the part-time program are equivalent to the current full-time MUFL program, but will be spread over eight instead of four instalments<sup>1</sup>. For the 2022/23 academic year, proposed part-time tuition instalments amounts are proposed at:

- Domestic students: \$2,601.00 per instalment for 8 minimum instalments, equivalent to \$20,808 in total
- International students: \$4,641.00 per instalment for 8 minimum instalments, equivalent to \$37,128 in total

These fees are subject to increases as approved by the Board. We hope to offer the part-time option in September 2023. There are no additional mandatory fees associated with the program.

# 1.0 Tuition Consultation: Master of Urban Forestry Leadership (MUFL)

A part-time option, in addition to the current full-time program, has the potential to increase the reach of the program especially as it has an international focus. As most prospective students are likely to be career professionals, this option would be more inclusive as already stated in the proposal. Furthermore, this option is likely to help students have more flexibility options with keeping their employments.

With respect to the tuition proposal, the proposal compares tuition to certain UBC programs, and the values seems to be comparable. However, it is more objective to compare tuition fees to other universities in North America with the same or similar program(s). This inter-varsity comparison could help show how the program competes internationally.

Furthermore, considering that the program is 100% online, as opposed to the hybrid method that was initially proposed during the program development. It is unclear why there is a wide margin in the tuition fees for domestic and international students. The proposed/current tuition for international professionals is approximately twice that of domestic professionals. We believe this aspect should be looked into and revised accordingly.

The proposal also states that there would be up to eight \$10,000 awards to students who demonstrate financial need. The impact of these awards can only be measured if an estimated number of intakes is provided. The estimate should show what percentage is for international and domestic students.

Dear Graduate Students Society,

Thank for your response on Dec 6, 2022 to student consultation regarding our proposal to create a new part-time, 25-month option for the existing Master of Urban Forestry Leadership (MUFL) program. Like you, we believe this option provides students a flexible option to keep their employment and thus contributes to alleviating financial stress during studies.

I wish to provide some further information in regards to the questions you raised about program tuition fees and the wide margin in the tuition fees for the domestic and international students. The full-time option of MUFL was approved by the Senate and Board in 2018; as such the tuition fees charged for the program were not part of this consultation as those have already been set. The consultation this time is regarding the new payment schedule for the proposed 25-month option, since a part-time option was not considered at the time of approval in 2018.

However, I wanted to show some comparison to other universities in North America which you requested. The following comparable US programs are also fully online:

- Oregon State University, Master of Natural Resources (45 credits): Out of State fees of USD \$560 per credit, totaling USD \$ 25,200 or CAD \$34,403.
- University of Florida, Master of Geomatics/Master of Forest Resources/Master of Conservation (30 credits): Out of the State fees of USD \$27,335 or CAD \$37,332.
- North Carolina State University, Masters of Forest Biomaterials: Out of the State fees of USD \$23,967 or CAD \$32,736.
- University of Idaho, Masters of Natural Resources: Out of State fees of USD \$23,046 or CAD \$31,378.
- Colorado State University, Masters of Natural Resources Stewardship (30 credits): Out of the State fees of USD \$24,312 or CAD \$33,197.

MUFL international tuition of CAD\$37,128 is slightly higher than the programs above. However, a \$10,000 scholarship to international students would reduce international tuition to only \$6,300 more than the domestic fee. In comparison, US out-of-the state tuitions are normally 2.5 times more than the in-state fees. We plan to offer up to ten \$10,000 international scholarships to students who enrol in either the full-time or part-time streams. As our enrolment target is 20-25 students across both streams (where up to 50% may be international students), nearly all international students will receive the scholarship. The total distribution of these scholarships will be determined through the evaluation of the applications submitted.

The Faculty of Forestry recently completed their student tuition consultation for their proposed parttime iteration of the existing Master of Urban Forestry Leadership. During this process they provided information about a new student award they plan to offer to international students to help reduce the high international tuition differential. They previously provided additional information noting that they plan to offer 10 awards per year for eligible international students in either the full-time or parttime option. Unfortunately, they have since learnt that, per existing Senate Policy on Students Awards, part-time students are not eligible for student awards.

The Faculty remains committed to offering 10 international student awards for eligible students in the full-time option. We apologize for this miscommunication.

I am recommending that the President approve a \$1,000 non-refundable acceptance deposit for domestic and international students apply to the Master of Urban Forestry Leadership (MULF) program in both the existing full-time option as well as the proposed part-time option, effective 2023/24 Winter Session, Term 1 (e.g., September 2023). Non-refundable deposits are levied when students accept an offer of admission; the deposits are applied to students' first tuition instalments.

# BACKGROUND

The Master of Urban Forestry Leadership (full-time option) was approved by the Board of Governors in April 2018. At that time, the Board approved a non-refundable acceptance deposit of \$1,000 for both domestic and international students, but due to an administrative oversight, the creation of this acceptance deposit was not approved by the President.

This oversight has been identified as a result of the Faculty seeking to establish a part-time iteration of the MULF program. The Faculty is requesting the same non-refundable acceptance deposit of \$1,000 for both domestic and international students for the part-time MULF program (pending Board approval).

The intent of the fee is to encourage applicants to make their acceptance decisions in a timely manner. The non-refundable acceptance deposit was included in the original student tuition consultation conducted between February – March 2018 and included in the student tuition consultation for the part-time iteration conducted between November – December 2022.
