For Information Board 4 Post-Completion Report | Undergraduate Life Sciences Teaching Labs Renewal, UBCV Board 4 post-completion reports are provided to the Board of Governors following the construction, occupancy and warranty period, as part of the project management process for construction projects over \$5,000,000.

The Undergraduate Life Sciences Teaching Labs Renewal was a complex project intended to provide modern teaching laboratories and classrooms for undergraduate students and offices for teaching faculty, completed for the start of winter session classes in 2019. The project renewed the seismically vulnerable Biological Sciences North wing (built 1976) and replaced the deteriorated Biological Sciences Centre Block (built 1948) with a new, five-storey Biological Sciences East wing. This completed the renewal of the aging Biological Sciences complex (the two research wings were renewed in 2012).

This briefing summarizes annual implementation milestones and achievements for the F2022-2023 year.

Together, these reports provide the Board of Governors with the information needed to assess the compliance of planning and development activity with UBC's land use policy targets and commitments.
