Action Identified Administration to provide an update at the next meeting as to when the action items identified in the March 21, 2022 Minutes of the Learning & Research Committee would be addressed: 1)The Administration's assessment of the resources that the University needs to secure (other than the funding packages) in the context of the current over enrollment in order to ensure highquality graduate education, resources that are currently not provided through government graduate funding.

- 2) A briefing with respect to the Administration's advocacy with government and the results of that advocacy (particularly with resect to the unfunded graduate FTE on the Okanagan campus) as well as consideration of other strategies/ approaches to secure required resources to sustainably fund core graduate education.
