

Attached is the schedule of Alma Mater Society of UBC Vancouver fees for the upcoming 2025-26 academic year. The table highlights changes to the majority of existing fees. All fees except the SUB Renewal, Athletics and Intramurals Benefit, Student Legal Fund, Graduating Class, Student Aid Bursary, Fitness and Recreation Building, and the Health and Dental Plan fees are indexed to the British Columbia Consumer Price Index of 2.65%.
